Undisputed Jr. Welterweight Championship
Jessica McCaskill vs. Chantelle Cameron

Dear Mr. Hearn:

Please be advised that his Committee hereby grants sanction approval for the above-referenced bout between Jessica McCaskill vs. Chantelle Cameron to be held on Saturday, November 5, 2022, at the Etihad Arena, Abu Dhabi, United Arab Emirates. This bout is sanctioned subject to the winner facing within 120-days after the bout the WBO Female Jr. Welterweight Mandatory Challenger Christina Linardatou.

Furthermore, Matchroom Boxing, Team Cameron, and Team McCaskill understand, agree, and accept all the conditions set forth herein and any other provisions hereinafter established by the WBO. Non-performance with the foregoing provisions will result in this Committee declaring the WBO Female Jr. Welterweight Championship title vacant "Ipso Facto" without no further notice, hearing and/or citation. This bout is governed by the WBO Rules and Regulations.

Also, be advised that if McCaskill wins the Vacant WBO Jr. Welterweight Championship, she has 10 days after the bout to determine which weight division she retains.¹ However, if McCaskill losses the bout against Cameron her WBO Welterweight Championship will be declared Vacant "Ipso Facto".

Conversely, sanction approval is hereby granted under the sole and exclusive responsibility of the promoter of the event concerning the compliance with all relevant health and safety protocols enforced by the Dubai Boxing Commission and all other laws, rules, and guidelines set forth by the relevant government authorities to ensure the participant's safety and well-being.

In closing, this Committee reserves the right to issue any further rulings deemed necessary, helpful, and convenient to accomplish the purposes, policies, and intent of the WBO rules, including, but not limited to
