Re: Purse Bid Order - WBO Middleweight Elimination Championship Contest
Denzel Bentley vs. Endry Saavedra

Gentlemen:

On July 14, 2025, this Committee ordered the commencement of negotiations for the subject matter bout. The parties were granted twenty (20) days to negotiate and reach an agreement accordingly. Notwithstanding the foregoing, the negotiation period referenced herein has elapsed without the parties being able to reach an accord.

Subsequently, the parties reached terms for the subject matter bout, and the bout was officially registered in the "BoxRec" database to be held on October 25, 2025, in the United Kingdom. However, Mr. Matt Rose, on behalf of Team Saavedra, communicated to the WBO that although the parties had agreed upon all terms, Queensberry needed to reschedule the bout due to other logistical considerations and indicated that they would be able to stage the event toward the end of the year.

Nonetheless, Team Saavedra objected to the rescheduling of the bout, and on October 7, 2025, Mr. Matt Rose submitted an email communication formally requesting that purse bid proceedings be called pursuant to the WBO Regulations of World Championship Contests.

Therefore, as per Sections 11 through 14 of the WBO Regulations of World Championship Contests, **IT IS HEREBY ORDERED** to conduct purse proceedings on Monday, October 27, 2025 at 10:00 a.m. (GMT-5 /Colombia Local Time) during the 38th WBO Annual Convention at the following venue:

The minimum acceptable bid for the WBO Middleweight Division is \$200,000.00 (Two-Hundred Thousand Dollars). The WBO President Gustavo Olivieri, Esq., will be presiding purse bid proceedings.

The applicable provisions for the Bentley/Saavera Middleweight Elimination Championship Contest are as follows:

SECTION 13. DIVISION OF PURSE FOR CHAMPIONSHIPS HELD PURSUANT TO PURSE BID

(a) The purse for Championship Contests held and completed pursuant to Purse Bids be distributed as follows:

(b) (2) VACANT CHAMPIONSHIPS or ELIMINATORY FIGHTS

(A) In fights for a vacant title or eliminatory fights the distribution shall be as follows:

(B) If the fight is held in the country of origin, residence or nationality of one of the contenders, the resident contestant shall receive 40% and his opponent shall receive 60% of the total purse offered.

(C) If the fight is held in a neutral place or if the contenders are from the same country of origin, residence or nationality, in such a way that neither have an advantage over the other, the purse shall be divided in equal parts between the contenders. USA Residents shall be considered of the same country of residence, regardless of which State they reside in for Purse Bid purposes.

Furthermore, the Committee sets forth the following provisions:

1. If any of the fighters suffer an injury, are impaired to fight, prevented to fight, refuse to fight or are unavailable to fight for whatever reasons or circumstances, the Committee shall proceed with taking any affirmative actions, including but not limited to (i) declaring the WBO Middleweight Participant(s) unavailable; (ii) selecting the next available contender(s) in the WBO Jr. Middleweight Division, and (iii) taking any other action pursuant to the WBO rules and regulations.
2. 20% of the total purse offers must be lodged to the WBO main offices in certified check, cashier's check, or bank money order payable to the WBO, or money in cash, in the legal tender of the United States of America (dollars) no later than 2 business days upon the adjudication of the purse bid.

However, all WBO Promoters have the option to lodge with the WBO main offices a corporate check subject to the preceding payment method being substituted for a wire transfer payable to the WBO main offices no later than 2 business days upon the adjudication of the purse bid. Failure to comply with this provision will result in the WBO Championship Committee declaring the winner of the purse bid in default automatically and awarding the promotional rights to the second-highest bidder per WBO Regulations.

3. The WBO Participants must confirm in writing to the WBO within 48 hours upon the adjudication of the bid promotional rights whether they are ready, willing, able, and available to proceed with the bout. Failure to comply with the foregoing condition will result in this Committee determining that the non-complaint WBO Participant is uninterested and unavailable to proceed, engage, participate or fight as ordered.
4. Executed Bout agreements shall be lodged with the WBO main offices within 5 days upon the adjudication of the purse bid.
5. Lack of television, broadcast or streaming network date does not constitute just cause for an extension of the bout being conducted within the outlined term in the applicable provisions unless otherwise authorized by the Championship Committee.
6. The winner of the purse bid proceedings must conduct the WBO Mandatory Jr. Middleweight Championship Contest no later than 90 days nor earlier than 45 days upon the adjudication of the purse bid.
7. The winner of the elimination bout will be designated the mandatory challenger of the WBO Middleweight Division; however, the Committee reserves the right to determine when deemed appropriate, the enforcement of the mandatory in the division.
8. The WBO Middleweight participants acknowledge, agree and accept the conditions set forth herein by the Championship Committee.
9. The Committee reserves its right to impose all further conditions during the purse bid proceedings.
10. Lastly, this Committee reserves its right to issue all further rulings deemed necessary, helpful, and convenient to accomplish the purposes, policies, and intent of the WBO Regulations of World Championship Contests, including serving the best interests of boxing and those in the WBO Jr. Middleweight Division.
