**Mikiah Kreps vs. Ramla Ali**

Gentlemen:

Please be advised that the WBO World Championship Committee hereby **ORDERS** the commencement of negotiations for the above-captioned Vacant WBO Female Jr. Featherweight Championship Contest.

The parties are hereby granted thirty (30) days from the date of this Order to negotiate and reach an agreement. Within said period, the parties shall advise the WBO, in writing, of the following:

1. The agreed official bout date;
2. The official venue where the contest shall be held;
3. The official broadcaster and/or media platform upon which the contest will be televised or streamed; and
4. The promoter(s) of record.

Upon written confirmation to the WBO that an agreement has been reached, the parties shall have an additional ten (10) days to submit fully executed copies of all bout agreements and all supporting contractual documentation pertaining to the subject contest.

Any party may request purse bid proceedings at any time during the negotiation period. Should the parties fail to reach an agreement within the thirty (30)-day period prescribed herein, the WBO shall order purse bid proceedings pursuant to the WBO Regulations of World Championship Contests.
