MINIMUM BID

Pursuant to the WBO Regulations of World Championship Contests, the minimum bid for the WBO Female Junior Featherweight Championship Division shall be Twenty Thousand Dollars (US \$20,000.00).

PURSE SPLIT

The World Boxing Organization ("WBO") hereby advises that, in light of the fact that the Vacant IBF Female Junior Featherweight World Championship will also be contested in the subject bout, the WBO World Championship Committee will confer with the International Boxing Federation ("IBF") Championship Committee for the purpose of establishing a uniform purse split applicable to the purse bid proceedings, thereby ensuring consistency and avoiding conflicting purse allocation percentages between the respective sanctioning bodies.

Upon reaching a determination, the applicable purse split shall be formally communicated to the respective promoters of Ms. Mikiah Kreps and Ms. Ramla Ali, and shall likewise be published through official public notices on the WBO's official website and official social media platforms, thereby providing timely notice to all bona fide WBO-licensed promoters interested in participating in the purse bid proceedings.

The WBO anticipates issuing such notice no later than Wednesday, July 22, 2026, unless otherwise determined by the respective Championship Committees.

ELIGIBILITY OF BIDDERS

Participation in these purse bid proceedings is limited to bona fide WBO-licensed promoters in good standing.

The successful bidder shall be required to comply fully with all applicable provisions of the WBO Regulations of World Championship Contests, including, without limitation, the timely execution of the Promotional Rights Agreement, payment of all applicable WBO championship fees, submission of the required purse bid deposit, and satisfaction of all applicable licensing, financial, contractual, and regulatory requirements prescribed by the WBO.
