**RE: WBO WELTERWEIGHT MANDATORY CHAMPIONSHIP CONTEST

Dear Promoters:

Please be advised that the World Boxing Organization (WBO) World Championship Committee has ordered purse bid proceedings for the WBO World Welterweight Mandatory Championship Contest between WBO World Welterweight Champion Devin Haney and Official Mandatory Challenger Keyshawn Davis.

On June 30, 2026, the World Championship Committee commenced negotiations by issuing a Negotiation Order granting the parties twenty (20) days to negotiate in good faith and reach an agreement for the mandatory championship contest. Having reached the expiration of the negotiation period without the submission of a duly executed Championship Agreement to the World Boxing Organization, the Committee has ordered purse bid proceedings pursuant to the applicable provisions of the WBO Regulations Governing World Championship Contests.

The purse bid proceedings shall be conducted by Gustavo Olivieri, Esq., President of the World Boxing Organization, pursuant to the WBO Regulations Governing World Championship Contests.

For purposes of transparency and the orderly administration of the championship process, the purse bid proceedings shall be broadcast live through the WBO's official website and all official social media platforms, thereby allowing the worldwide boxing community to observe the proceedings.

MINIMUM ACCEPTABLE BID

The minimum acceptable bid for this championship contest shall be:

US \$200,000.00
(Two Hundred Thousand United States Dollars)

PROMOTER ELIGIBILITY

Participation in these purse bid proceedings shall be limited exclusively to WBO-licensed bona fide promoters in good standing.

The World Championship Committee expressly reserves the right to verify the licensing status, eligibility, and good standing of every prospective bidder prior to accepting any bid. Any promoter who fails to satisfy the applicable licensing requirements or otherwise does not meet the eligibility criteria established under the WBO Regulations Governing World Championship Contests may be declared ineligible to participate in these proceedings.

Only those promoters determined by the World Championship Committee to be duly licensed, qualified, and in good standing with the World Boxing Organization shall be permitted to submit a purse bid.

The Committee further reserves the right to reject any bid or disqualify any prospective bidder who fails to comply with the WBO Regulations, the conditions governing these proceedings, or any ruling or directive issued by the World Championship Committee.

APPLICABLE REGULATIONS

The purse bid proceedings shall be conducted in accordance with Sections 11 through 14 of the WBO Regulations Governing World Championship Contests, including all applicable provisions governing purse bid procedures, promoter eligibility, promoter obligations, purse bid deposits, promotional rights, championship contracts, promoter default, and all other matters pertaining to the conduct of these proceedings.
